Information for new owners

As soon as you take ownership of a pet, you must register them on the NSW Pet Registry and pay the registration fee if the pet is not yet registered.

The person who has sold or given this pet to you is responsible for submitting this form to council for processing. They should give you a copy for your records. If the person fails to give the form to council and change ownership into your name, you can use the copy to process the change.

Give it to your local council alongside a statutory declaration to claim official ownership of your pet. This must include:

- · your name and address
- the pet's microchip number
- the details of how you came to own the pet, which you are declaring to be true
- your signature and the signature of an authorised witness (this can be a Justice of the Peace (JP), a legal practitioner or a notary public)
- the date and location where the declaration was made.

Once the change of ownership is processed, you will get a Certificate of Identification or a Certificate of Registration from council (depending on whether registration has been paid).

Information for those selling or giving away a pet

It is your responsibility as a breeder or former owner of a pet to fill out this form and give it to your local council. You must do this within 14 days of selling or giving the pet away. Please give the new owner a copy of the completed form for their records.

How to find your pet's microchip number

If you don't know your pet's microchip number, please check your records (it may be listed on documents from your vet). Otherwise, have your pet scanned at a vet or with a council ranger to find the number.

Privacy information

Only authorised people can access the information provided on this form, and only to enforce the *Companion Animals Act 1998*.

If you are concerned that disclosure of your information could jeopardise the safety of you or your family, you may request that these details be suppressed. Please contact any NSW local council for more information.
